# **New Convert Subsidy**

## **Purpose**

To encourage new converts or the children of new converts to be enrolled in a K-12 Seventh-day Adventist school.

## **Identity of New Convert**

1. One joining the Seventh-day Adventist Church through baptism or profession of faith within the 18-month period prior to school enrollment.
2. If school-age children have joined the Church, the parent(s) or guardian(s) must either have joined the Seventh-day Adventist church within the last 18 months as well or not be members of the Church.

## **Benefits**

1. 75% tuition only to be paid by NCC, the local church, and the school during the first semester of enrollment.
2. 50% tuition only to be paid by NCC, the local church, and the school during the second semester of enrollment.
3. 25% tuition only to be paid by NCC, the local church, and the school during the second year of enrollment.

## **Eligibility**

1. Church membership will have been established during the eighteen-month period immediately preceding school enrollment.
2. Benefits will apply to students who are initially enrolled in a Seventh-day Adventist school within the 18-month period.

## **Procedures**

1. Schools will certify to the Office of Education by name and school those students who are enrolled under these criteria.
2. Funding of the discount will include 60% contribution by NCC, 20% by the church, and 20% by the school.

# Subsidio para los Recién Bautizados

## **Propósito**

Animar a los recién bautizados, o los hijos de los recién bautizados, a matricularse en una escuela adventista en los grados K – 12.

## **¿Quiénes tienen derecho?**

1. Pueden solicitar esta beca los que se unen a la Iglesia Adventista del Séptimo Día por medio del bautismo o profesión de fe 18 meses antes de matricularse en la escuela.
2. Si un niño de edad escolar es quien se ha bautizado, sus padres no pueden ser miembros, o su padre/madre/guardián también debe haber sido bautizado durante los últimos 18 meses.
